Business Experience

Before studying for my PhD, I spent eleven years as a manager and director for consumer cooperatives in the United States. The organizations involved were in grocery retail and wholesale, and in student housing and food service. This practical experience in strategy, finance, personnel, and operations has been invaluable for me in research, teaching, and administration.

Business Consultant, 1985 – 1987. My clients were cooperatives in the wholesale and retail trade in both California and Massachusetts, and also the National Cooperative Business Association (Washington, D.C). Projects included executive recruitment, feasibility studies for new ventures, and interim management of operations.

Consumers Cooperative of Berkeley, Berkeley, California, 1979-1984. This was at the time the largest consumer grocery co-operative in the U.S., with fourteen stores, annual sales of over \$75 million, and over 400 employees. I was elected twice to the **Board of Directors**, serving 1979-1984. I served as **President** of the Board for two years, 1983-1984.

University Students' Cooperative Association, Berkeley, California, 1976-1984. The USCA is the largest student housing cooperative in North America. At the time I worked there we had 1,500 members living in 18 self-managed buildings. The full-time positions I held were **Director of Food Service (1981-84)**: I oversaw decentralization of food preparation from one central kitchen to fifteen satellite kitchens, and changed procurement from an inventory-based to just-in-time delivery; and **Director of Technical Assistance (1979-80)**, providing consultancy services to new housing cooperatives at other universities, under contract for the National

Cooperative Bank. Prior to that I had served in the part-time roles of **President**, 1978-79: during my term, we obtained land and Federal (HUD) financing for, and began planning of, a new apartment complex for 102 students, opened in 1981; and purchased and opened another building, a dormitory housing 52 students; **Director of Member Education**, 1977-78; **Vice-President**, 1976-77.
